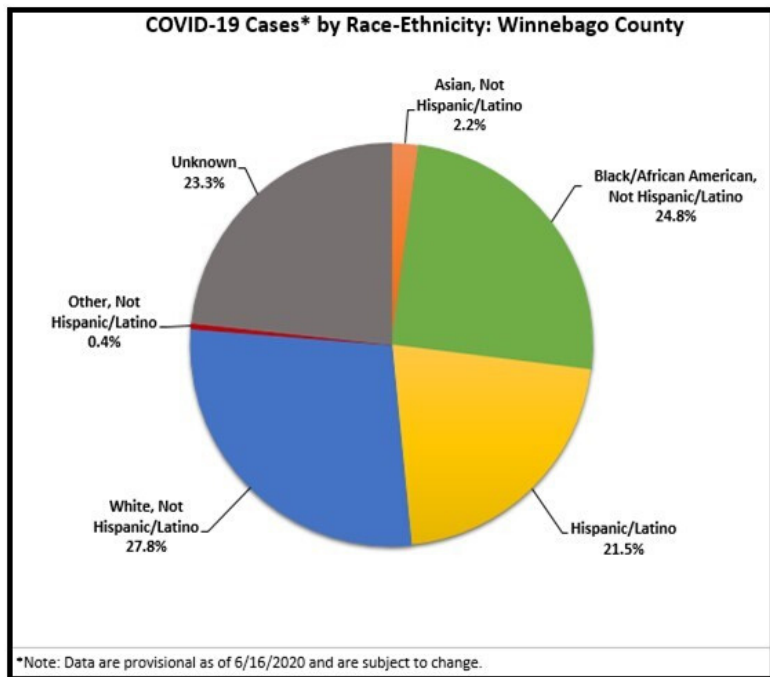

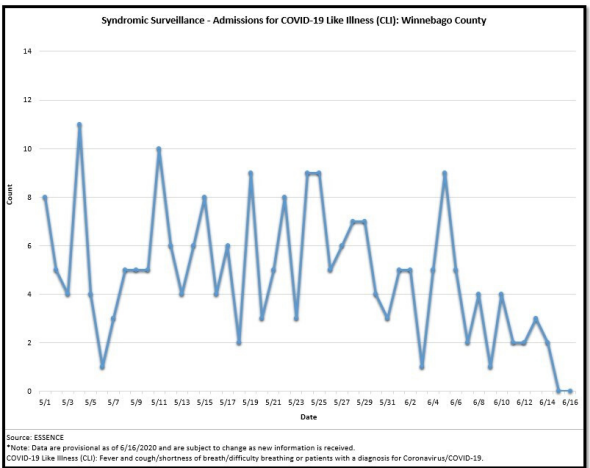
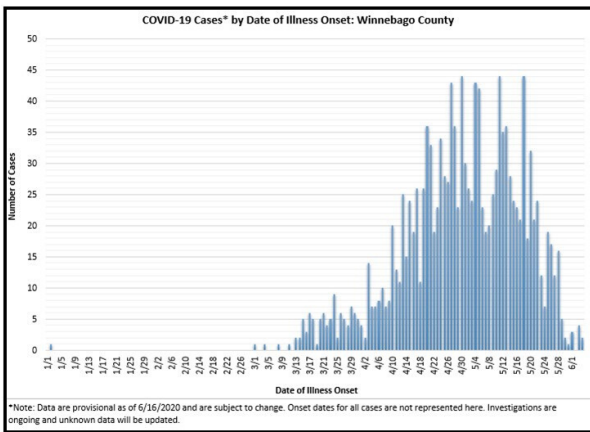
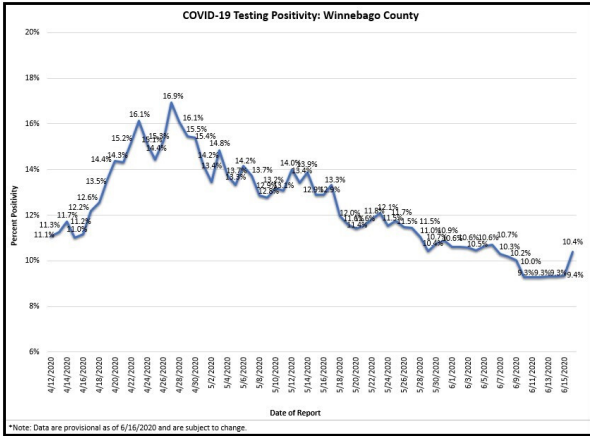
COVID-19 Testing for Winnebago County*

The total number of negative tests reported today is lower than previous reports. One lab recently began reporting negative results electronically and continued to report them manually. This issue has been identified and corrected. Today's number reflects the unduplicated number of negative tests to date.
