Winnebago County Health Department releases this daily report to update the community on the number of COVID-19 cases in the county and the resources that are needed to address the cases.

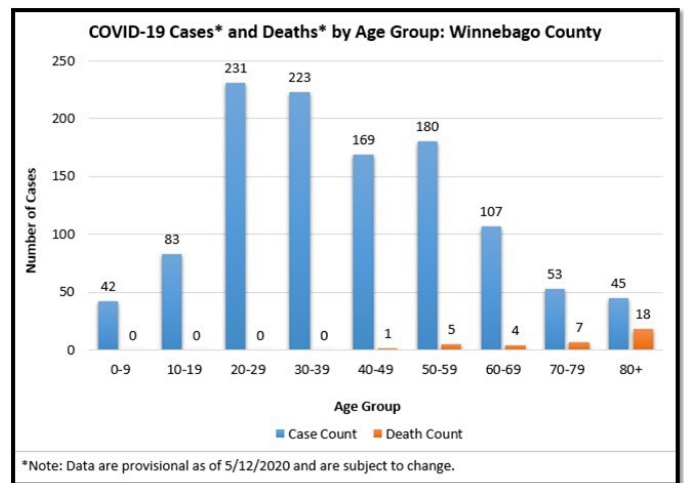
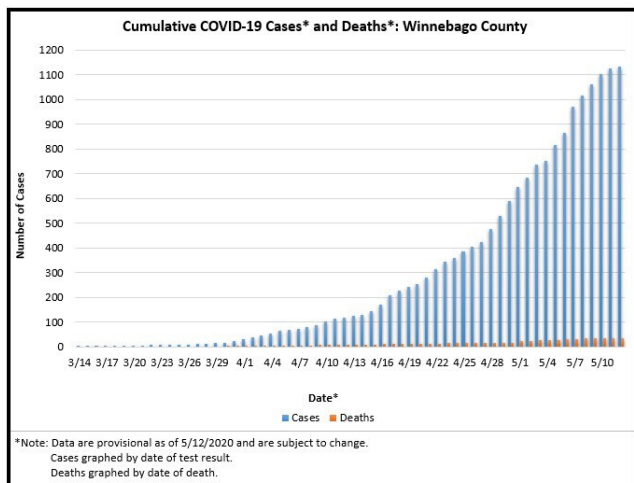
